This collection is comprised of approximately 17,000 pages of U.S. Bureau of Immigration case files for Mexican immigration from 1900 to 1932, during a period when the Mexican-born population of the United States grew from 1,400,000 to 2,400,000. The Mexican Revolution, job opportunities during World War I, and long-term transformation contributed to Mexican immigration to the United States during this time period. Collection materials include reports from across the borders of Texas, New Mexico, Arizona, and California, as well as immigrants from other countries who entered the United States by way of Mexico.

Admissions, Boards of Inquiry, and Changing Rules

A large portion of the collection consists of documents presented at boards of inquiry regarding the admission of immigrants to the United States. The documents include transcripts of board proceedings that inquire into immigrants' qualifications for admission, determine whether the requirements of immigration regulations have been met. Additionally, there is information on family size, education, occupation, health, immigrants' origins and destinations, and public assistance. Also included in the collection are documents describing negotiations between the United States and Mexico regarding immigration legislation. Between 1912 and 1924, Congress passed legislation supported increased restrictions on immigration in order to meet agricultural labor demands during World War I. Congress temporarily suspended American immigration laws in 1918. This allowed the influx of Mexican immigrants who would not have otherwise been permitted into the United States.

Border Conditions

Documents in this collection also report on the conditions along the U.S.-Mexico border at ports of entry in Texas, Nogales and Naco, Arizona, and Tijuana and San Diego, California. These reports discuss health conditions, refugees, the construction of refugee camps, smuggling activity, the local labor supply and demand situation, and the Mexican origins and destinations of immigrants. In addition, a number of documents describe the activities of Immigration Service officials in El Paso, Texas, who maintained the Mexican Border District's central office. This office also controlled investigations of abuse and corruption by Immigration Service staff at various ports of entry. A number of reports address the efforts of European, Middle Eastern, Chinese, and Japanese immigrants on the Mexico-U.S. border, as well as Mexico's treatment of them.

Economic Opportunities

During the 1920s, approximately 500,000 Mexicans entered the United States legally, while a comparable number of undocumented immigrants entered the United States.

Politically, the committee said, propaganda was successfully distributed. The materials included an appeal from the National Liberation Front Central Committee, an order from headquarters of the South Viet-Nam Liberation Army, a letter from the Central Office of South Viet-Nam (PRP headquarters) and "victory news".

However, in overall assessment, the committee found that political agitation and proselyting were unsuccessful in inspiring a popular uprising. "The people's spirit for uprising is still very weak when compared with the requirements and with the new capabilities and advantages," it said. "It / the uprising attempt / was not well coordinated with the military offensive."

Commenting on another aspect of the attacks, the critique concluded, "The mobilization of manpower and resources to build up and expand our forces brought about good results at some places but still lagged behind the fast developing situation."

The second document presented is a circular which outlines the post-Tet mission of VC units active in Mekong Delta province. Captured February 25, the circular was originally issued by the PRP Standing Committee of VC Can Tho Province (GVN Phong Dinh Province).
